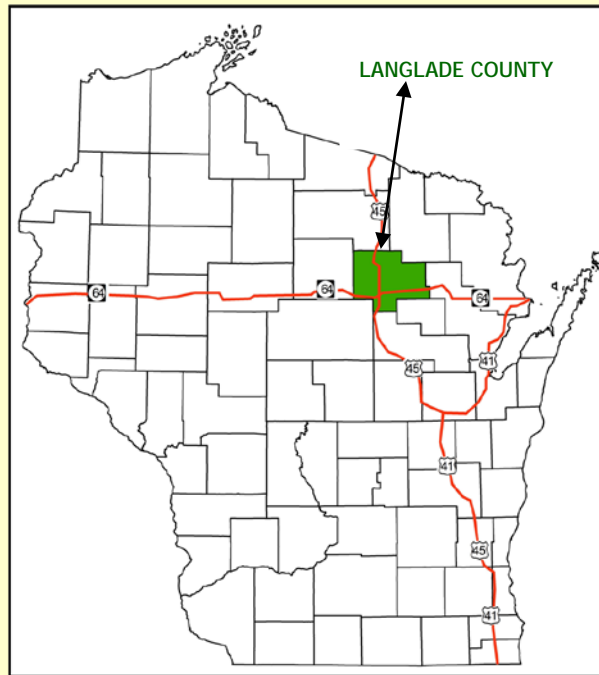

Langlade County welcomes and encourages your special event reservation at our Fairgrounds. To make special event reservations, please call (715) 627-6307.

The Langlade County Fairgrounds is conveniently located on Hwy 45, an excellent location for large or small events with easy access. The Langlade County Fairgrounds is a modern, well lit-maintained 55 acre facility with complete perimeter fencing, access via three (3) vehicle gates, ample electrical power supply, three (3) acres of paved parking area, eight (8) acres of mowed grass parking area, modern buildings, ½ mile lighted clay race oval with eight (8) acre pit area, hot pit area and vehicle scale, covered grandstand, WI-FI, and overflow offsite parking and now the new Langlade County Livestock Pavilion. All located within minutes of shopping fuel, food, motels and downtown Antigo.

### SECURITY

Large events are required to obtain security from the Langlade County Sheriff's Department. Lessee will be responsible for overnight security. Lessee is required to inform the Sheriff Department and Fairgrounds Committee who will be responsible for overnight security.

## Langlade County Fairgrounds

### REQUIRED MEETING

Festival organizers are required to attend a meeting with the Langlade County Fairground Promotional Committee prior to your event.

### RULES

A non-refundable deposit will be required for the event and be applied to the cost of the lease. If the event is cancelled at least 60 days prior to the event, the scheduling deposit will be returned.

All event dates must be scheduled at least two months prior of the event.

Any electrical changes must be approved by the Fairground Committee at least thirty (30) days prior to your event.

No music or speaker system can be used or tested between 10pm and 9am. Noise ordinance waivers should be requested from the City of Antigo if needed.

Lessee will provide a Certificate of Insurance to the Fairgrounds Committee at least thirty (30) days prior to your event.

## Langlade County Fairgrounds

### BUILDING INFORMATION

**Grandstand/Grounds:** Covered Grandstand. Rental fee is \$550 per day and \$300 per day for Non-profit organizations. This fee includes restroom facilities except for the cost of supplies-and will include use of the Sound System and grounds.

**Multipurpose Building:** 25,680 Square Feet. Rental fee is \$550 per day and \$300 per day for non-profit organizations. This fee includes the use of the Clover Room, kitchen and restroom facilities except for the cost of supplies. If using kitchen appliances, a separate \$100 fee will apply.

**Commercial Building:** 7,320 Square Feet. Rental fee is \$100 per day.

**Exhibition Building:** 8,720 Square Feet. Rental fee is \$100 per day.

**Livestock Pavilion:** 4,800 Square Feet center with two (2) wings at 4,753 square feet each. Rental fee includes the center and two (2) wings. Rental fee is \$300 per day and \$200 non-profit.

**4-H Food Stand Kitchen:** 2,400 Square Feet. It includes a deep fryer, grill, gas stove, walk-in freezer, 2 upright coolers and triple basin washing sink and stainless steel countertop. Rental fee is \$100 per day

Please contact the Langlade County Fairgrounds to clarify capacity for each building to make sure that the facility you choose will meet your needs.
