

**LANGLADE COUNTY BOARD OF SUPERVISORS  
BI-MONTHLY INFORMATIONAL MEETING – APRIL 3, 2017**

The Langlade County Board of Supervisors met at the County Board Room in the Safety Building. Chairman David Solin called the April 3, 2017 Bi-Monthly Informational Meeting of the County Board to order at 6:30 p.m.

On call of the roll, all Supervisors reported present, except Supervisor Burby, Webb, Poltrock and Schreiber. 17 Supervisors present.

The Board recited the Pledge of Allegiance and observed a moment of silence.

**Committee Reports:**

**Land Records & Zoning:** Duane Haakenson, Zoning Administrator, handed out his Department Organizational Chart, explaining to the Board the various positions within the Land Records and Regulations Department. Joe Martell then handed out and explained a map showing which areas in the State have completed GIS Mapping.

**Veterans:** John Zenkovich, Veterans Service Officer for Langlade County, stated that his Department, himself and one full time employee, offer Veterans such services as Medical, Benefits, and Burial Honors, along with going paperless, their office will be making on site visits.

**Clerk of Courts:** Marilyn Baraniak, Clerk of Court, explained the process that her office has gone through to get to the E-filing process that will go into effect this Spring. All case types filed in the office, Family, Criminal, Small Claims, will follow this procedure. Along with the Clerk, there are five full-time employees in the Clerk of Courts Office.

**ADRC-CW:** Linda Weitz, Executive Director for Aging and Disability Resource Center of Central Wisconsin, handed out a report explaining the services that Langlade County aging and disabled adults have received over the last six years. Some of the services that are available are: benefits, counseling, healthy living, and nutrition.

**Health Department & Social Services:** Ron Barger, Health and Social Services Director, distributed to the Board several handouts, along with his Organizational Chart for his Departments and his 2016 Annual Report. Some of the services that are available include Children and Family Services, Energy and Weatherization Assistance, Economic Support, and Juvenile Justice. Tracy Chernetski, CSW Social Worker Supervisor handed out and explained to the Board her statistical report for 2017. Rylee Bricko, Social Worker, shared her caseload report to the Board.

**Register of Deeds:** Chet Haatvedt, Register of Deeds, gave a slide presentation on the type of documents, the information that the documents contain, and the parties that file such documents and the number of filings in the Register of Deeds Office. The Register of Deeds Office can now issue birth, death, marriage and divorce certificates statewide.

**ITBEC – International Trade, Tourism, Business and Economic Council** represented by Angie Close and Michael Klimoski. Langlade County is one of eleven counties that represent the Northcentral Regional ITBEC. Some of the activities of ITBEC include Marketing, Sport Shows, Brochures and Online Marketing, all used to enhance economic activity in the region.

**Any other business that may lawfully come before the Board:** none.

Motion was made by Supervisor Pennington, seconded by Supervisor Hurlbert, to adjourn the meeting at 8:50 p.m. All Supervisors present voted aye. The motion carried, meeting adjourned.
