

**Town of Antigo
Town Board Meeting
August 12, 2015**

Chairperson Rick Parilek called the Monthly Board Meeting to order on August 12, 2015 at 7:30 p.m. at the Antigo Town Hall. Other Board members present were Supervisor Jon Petroskey, Supervisor Wayne Schroeder, Clerk Rosemary Servi and Treasurer Cindy Igl.

The clerk read the minutes of the prior month's meeting. The minutes were approved with a motion by Jon and second by Wayne. Motion carried.

Present were the following officers of the Antigo Area ATV/UTV Club – Pete Pennington, Jack Anderson and Tom Stanek. They requested that the Town Board renew the current All Terrain Vehicle and Utility Terrain Vehicle Route Ordinance. Jon motioned to renew the current All Terrain Vehicle and Utility Terrain Vehicle Route Ordinance with no end date. Rick seconded. The town may rescind the ordinance at any time for any reason. Motion carried. The amended ordinance notice of inspection will be published before our next board meeting before it is formally adopted.

Tom Waidelich, of Greater Insurance Service Corp., was present to submit his quote for insurance for the town. The quote was for \$15,004 which does not include cyber coverage and accident & sickness coverage as he is still getting the quotes for them. Jon motioned to stay with our current carrier, The Horton Group, for the town insurance. Wayne seconded. Motion carried.

Tom Wild was present in regard to his request to rezone between 6 – 6.25 acres from A-1 to Commercial. This farm land is directly behind Swiderski Equipment which they want to use for future expansion. The adjacent land on the east side of this farm land is zoned commercial and located on Highway 45. Wayne motioned to approve Tom Wild's request to rezone between 6 – 6.25 acres directly behind Swiderski Equipment from A-1 to Commercial. Jon seconded. Motion carried. A copy of the minutes and the signed Board meeting approval will be forwarded to the Langlade County Zoning Office.

The treasurer's report showed a checking balance of \$10,224.70, savings balance of \$381,147.95 and tax account balance of \$162,120.35 for a total of \$553,493.00.

Jon motioned that the town purchase an additional refurbished Edge voting unit from Command Central for \$2,250. Wayne seconded. Motion carried.

A motion was made by Jon to sell 26 old steel folding chairs that the town has for \$2 each on a first come first served basis with no warranty and the buyer releases the Town of Antigo from all liability. This will be by notice posted in the town's 3 posting locations. Rick seconded. Motion carried.

Our next Board Meeting will be held on Wednesday, September 9th at 7:30 p.m.

All approved bills were paid.

The meeting was adjourned at 10 p.m.
