

**Town of Antigo  
Town Board Meeting  
June 12, 2013**

Chairperson Rick Parilek called the Monthly Board Meeting to order on June 12, 2013 at 7:30 p.m. at the Antigo Town Hall. Other Board members present were Supervisor Jon Petroskey, Supervisor Wayne Schroeder, Clerk Rosemary Servi and Treasurer Cindy Igl. Also present were Ken Waldvogel, Bob Hunter, Nancy Hunter and Ron Pizl.

The clerk read the minutes of the prior month's meeting. The minutes were approved with a motion by Wayne and second by Jon. Motion carried.

Ken Waldvogel addressed the Board regarding the ditch in front of the Schremp property at 102 North Avenue. Ken would like to fill it in enough so it can be mowed. The Board was fine with the request. A copy of these minutes will be forwarded to Dan Schremp at 2003 Neva Rd., Antigo.

Bob and Nancy Hunter were present in regard to their alcohol beverage license for Northern Roots, LLC at 2914 Hwy 45 North. They will be selling locally grown and locally made products in addition to beer and liquor. Jon motioned to approve the alcohol beverage license contingent upon no problem for Northern Roots, LLC for the period 7/1/13 – 6/30/14. Wayne seconded. Motion carried.

Jon made a motion for Ron Pizl to be the town constable effective today, June 12<sup>th</sup>. Wayne seconded. Motion carried. An oath of office form was completed by Ron.

A motion was made by Jon and seconded by Wayne to approve alcohol beverage licenses contingent upon no problem for Rick's 45 Roadhouse, LLC, Draeger Oil Co., Inc. for BP North, and J Dubbs, LLC for J's Archery Pro Shop for the period 7/1/13 – 6/30/14 and also to approve Operator Licenses for the period 7/1/13 – 6/30/14 for the following: Megan Jaje, Ashley Steber, Haylee Shields, Mindalyn Schmit, Carl Opper, Brian Waldvogel, Cristy Arndt, Jessica Filbrandt, Jeremiah Rotzoll and Jillene Kapusta. Motion carried.

A written request was received from Mike Winski asking that his hourly wage be increased from \$10 per hour to \$12 per hour for town hall mowing and maintenance. Wayne motioned to raise Mike Winski's hourly rate from \$10 to \$11 effective July 1, 2013. Jon seconded. Motion carried.

Jon motioned to adopt Resolution #1-13 Emergency Operations Plan for the Town of Antigo. Wayne seconded. Motion carried.

Rick made a motion to go with the Langlade County Highway Department's estimates for the alternate Center Street paving for \$11,240 and for North Avenue crack-sealing on the Town of Antigo's portion for \$3,220. Jon seconded. Motion carried.

The treasurer's report showed a checking balance of \$7,292.52, savings balance of \$474,195.56 and tax account of \$10 for a total of \$481,498.08.

All approved bills were paid.

A motion was made to adjourn by Wayne at 8:55 p.m. Jon seconded. Motion carried.
