

**Town of Antigo  
Town Board Meeting  
June 15, 2016**

Chairperson Rick Parilek called the Monthly Board Meeting to order on June 15, 2016 at 7:30 p.m. at the Antigo Town Hall. Other Board members present were Supervisor Jon Petroskey, Supervisor Wayne Schroeder, Clerk Rosemary Servi and Treasurer Cindy Igl. Also present were resident Justin Eldridge, Taylor Tauer from Northeast Asphalt, Inc. and Nick Novy from American Asphalt of Wisconsin.

The clerk read the minutes of the prior month's meeting. The minutes were approved with a motion by Jon and second by Wayne. Motion carried.

Justin Eldridge was present in regard to rezoning parcel #006-0473.001 in Tresha Vaughn's name (who is his wife) from A-1 to Commercial for an auto repair business at W8339 Forrest Road. Justin stated that he put up a 30x40 shop a couple years ago and put a car lift in there. He wants to have an auto repair business out of his shop. The Board stated that the town plan does not recommend commercial property in that area. The Board recommended that Justin contact the County for a Conditional Use Permit. Rick motioned to not approve the zoning request from A-1 to Commercial for Parcel #006-0473.001 for Tresha Vaughn and Justin Eldridge. Wayne seconded. An oral vote was taken. There were three ayes and no nays. Motion carried. A copy of the form stating the Board's denial will be forwarded to the Langlade County Land Records & Regulations Department.

Bids for Dorr Street roadwork were opened. Northeast Asphalt, Inc. bid was \$27,767.60, American Asphalt of Wisconsin bid was \$29,270.20 and the estimate from the Langlade County Highway Department was \$21,744.00. Jon motioned to go with the Langlade County Highway Department's estimate of \$21,744.00. Wayne seconded. Motion carried.

A motion was made by Wayne to go with the Langlade County Highway Department's crack sealing estimates totaling \$21,222 which includes Dorr Street \$3,495, Duchac Street, \$2,247, Barnard Street, \$1,998, Gowan Road \$2,996, Industrial Park Road \$2,246, North Clermont Street \$2,496, Mourning Dove Lane \$1,748, Vista Lane \$1,998 and Ar-Vi Lane \$1,998. Jon seconded. Motion carried.

Jon motioned to approve Robert Barske's zoning request from A-2 to AFR for 3 acres on parcel #006.0297.002 for residential use. Wayne seconded. Motion carried. A copy of the form stating the Board's approval will be forwarded to the Langlade County Land Records & Regulations Department.

A motion was made by Jon and seconded by Wayne to go with the town hall roof repair bid of \$12,025 from Schweitzer Spray Coatings, LLC. Motion carried.

Wayne motioned to pay Mike Winski \$12 per hour for helping with road maintenance and spraying weeds. Jon seconded. Motion carried.

Jon motioned to approve a Class A liquor license for Draeger Oil Co., Inc. for CA Northside LLC/BP North for the period 7/1/16 – 6/30/17. Wayne seconded. Motion carried.

A motion was made by Jon to approve Operator Licenses for the period 7/1/16 – 6/30/17 for Jessica Filbrandt and Kate Filbrandt. Wayne seconded. Motion carried.

The treasurer's report showed a checking balance of \$4,805.70, savings balance of \$430,466.19 and tax account balance of \$175,354.90 for a total of \$610,626.79.

Our next Board Meeting will be held on Wednesday, July 13<sup>th</sup> at 7:30 p.m.

All approved bills were paid.  
The meeting was adjourned at 9:10 p.m.
