

Town of Antigo
Board of Review to Order and Adjourn
Town Board Meeting
May 11, 2016

Chairperson Rick Parilek called the Board of Review to order on May 11, 2016 at 7:30 p.m. at the Antigo Town Hall. A motion was made by Jon to adjourn the Board of Review to Tuesday, June 14th at 7 p.m. Wayne seconded. Motion carried.

Chairperson Rick Parilek called the Monthly Board Meeting to order. Other Board members present were Supervisor Jon Petroskey, Supervisor Wayne Schroeder, Clerk Rosemary Servi and Treasurer Cindy Igl.

The clerk read the minutes of the prior month's meeting. The minutes were approved with a motion by Wayne and second by Jon. Motion carried.

A motion was made by Wayne and seconded by Jon to approve alcohol beverage licenses contingent upon no problem for Rick's 45 Roadhouse, LLC, Draeger Oil Co., Inc. for CA Northside LLC/BP North, J Dubbs, LLC for J's Archery Pro Shop and for Northern Roots, LLC for the period 7/1/16 – 6/30/17. Motion carried.

Jon motioned to approve operator license's for the period 5/11/16 – 6/30/16 for Katie Wierschke and Justina Lewis. Wayne seconded. Motion carried.

A motion was made by Jon to approve Operator Licenses for the period 7/1/16 – 6/30/17 for Brian Waldvogel, Natosha Zoern, Jamie Greening, Connie Piotrowski, Megan Jaje, Justina Lewis, Katie Wierschke, Jeremiah Rotzoll, Rebecca Stewart, Kathy Wendt, Morgan Migas, Tracey Nelson and Shryl-Anne Hull. Rick seconded. Motion carried.

Wayne motioned to adopt Ordinance No. 143 Ordinance to Establish Procedures and Criteria for Allowing Alternative Forms of Sworn Testimony at Board of Review (BOR) Hearings. Jon seconded. Motion carried. Notice of the ordinance adoption will be posted.

A motion was made by Jon to appoint Cindy Igl and John McCullough as alternates for the Board of Review. Wayne seconded. Motion carried.

Wayne motioned to adopt Ordinance #137-1 Amendment to Ordinance #137 Establishing Seasonal Weight Limits. Jon seconded. Motion carried. The notice of ordinance adoption will be published in the paper and posted.

Jon motioned that any current member of the Town of Antigo Volunteer Fire Department listed as a current employee on the Town's employee records, could mow the town hall lawn in place of Mike Winski and for the same hourly rate Mike Winski is receiving at that time. Wayne seconded. Motion carried.

A motion was made by Jon to approve the following projects estimated by the Langlade County Highway Department: Orchard Road \$2,380.14, Stoney Road \$3,824.44 and North Avenue \$3,042.87. Also a request was made for the Langlade County Highway Department to roll the town hall lawn edges (as needed), only 10-12 feet in from the edge. from damage done to edges of lawn when Langlade County plowed snow. Wayne seconded. Motion carried.

The treasurer's reports showed a checking balance of \$18,773.99, savings balance of \$429,350.47 and tax account balance of \$175,354.90 for a total of \$623,479.36.

Wayne motioned that Cindy may get a laptop computer for the treasurer work with a cost to not exceed \$500. Jon seconded. Motion carried.

The Open Book will be held by Gene Matuszewski, Jr. on Tuesday, June 7th from 11 a.m. to 1 p.m.

The Board of Review will be held on Tuesday, June 14th from 7 p.m. to 9 p.m.

Our next Board Meeting will be held on Wednesday, June 15th at 7:30 p.m.
