

**Town of Antigo
Public Budget Hearing
Special Town Meeting of the Electors
Monthly Board Meeting
November 11, 2015**

Chairperson Rick Parilek called the Public Budget Hearing to order on November 11, 2015 at 7 p.m. at the Antigo Town Hall. Other Board members present were Supervisor Jon Petroskey, Supervisor Wayne Schroeder, Clerk Rosemary Servi and Treasurer Cindy Igl. Also present were residents Mike Winski, Mary Winski, Jim Frisch, Becky Frisch, Cal Krueger, Paula Krueger and John McCullough.

The proposed budget of \$409,809 was reviewed. The budget is a 4.74% increase.

Mary Winski motioned to adjourn the Public Budget Hearing. John McCullough seconded. A show of hands vote was taken. There were twelve in favor. No one opposed. Motion carried.

The Special Town Meeting of the Electors was called to order.

A motion was made by John McCullough to pass Resolution #4-15 for Electors to Exceed the Levy Limits at a Special Town Meeting of \$15,000 over the allowable 2015 town tax levy to be collected in 2016. Cal Krueger seconded. A show of hands vote was taken. There were twelve in favor. No one opposed. Motion carried.

Becky Frisch motioned to pass Resolution #5-15 for Electors to Adopt the Town Tax Levy at a Special Town Meeting of the Electors of \$266,455 for the 2015 tax levy to be collected in 2016. Mary Winski seconded. A show of hands vote was taken. There were twelve in favor. No one opposed. Motion carried.

A motion was made by Mike Winski to adjourn the Special Town Meeting of the Electors. John McCullough seconded. A show of hands vote was taken. There were twelve in favor. No one opposed. Motion carried.

At that point, all residents left except for John McCullough.

The Monthly Board Meeting was called to order.

The clerk read the minutes of the prior month's meeting. The minutes were approved with a motion by Jon and second by Wayne. Motion carried.

A motion was made by Jon to adopt the 2016 summary budget of \$409,809 as published in the Antigo Daily Journal. Wayne seconded. Motion carried.

Fire protection contracts for 2016 with Polar and Price were presented. Wayne motioned to sign the contract with Polar for \$11,654 plus the EMS charge of \$152 and with Price for \$10,522 plus the EMS charge of \$32. Jon seconded. Motion carried. Contracts will be sent to Polar and Price for their signatures.

Jon motioned to approve operator licenses for Morgan Migas and Kathy Wendt. Wayne seconded. Motion carried.

The treasurer's report showed a checking balance of \$6,264.48, savings balance of \$364,365.27 and tax account balance of \$162,283.40 for a total of \$532,913.15.

The Town's insurance renewal was gone through. The Board would like to decrease the personal property value in the town hall to \$30,000 and in the shed to \$200. The Board is also requesting quotes on the auto insurance with deductibles of \$500/\$500 and \$1,000/\$1,000.

Our next Board Meeting will be held on Wednesday, December 9th at 7:30 p.m.

All approved bills were paid.
The meeting was adjourned at 8:40 p.m.
